

Red Dress Luncheon & Fashion Show

The Second Annual Red Dress Luncheon and Fashion Show was held February 2, 2007 at the Country Club of Landfall. With nearly 500,000 women dying each year from cardiovascular disease, the NHRMC Foundation and Coastal Heart Center join together each February to host the Red Dress event to raise awareness of and funds for the prevention of heart disease in women.

This year's Red Dress proceeds will be used to fund cardiovascular screenings through the NHRMC Coastal Care Van in New Hanover, Pender and Brunswick County. These screenings will help identify women with high risk factors so they can be proactive in preventing heart disease for themselves and their family.

The keynote speaker at this year's event was Ms. Leslie Davis, RN, ANP - an author and expert on women and heart disease from UNC-Chapel Hill. Ms. Davis provided an important educational component, not only during her address at the luncheon, but earlier in the day by presenting at a special Nursing Grand Rounds.

Grand Rounds was attended by over 60 RNs that morning. In addition every patient tray for the day included an educational card. Staff distributed heart disease quizzes that were completed by over 200 staff and visitors.

All participants in this year's sold out event will help spread the word that heart disease in women is preventable and that understanding the risks can make all the difference.
